IMPORTANT INFORMATION ABOUT UPCOMING STORAGE

AT THE GENESEE COUNTY FAIRGROUNDS

First, let me start off by saying thank you to those that stored with us last year! Thank you for being so patient with us when COVID-19 hit our State and we had to make appointments for each of you to take out your items. We appreciate you working with our volunteers during this unprecedented time. Please wear your mask when bringing your item in for storage.

Storage Date

This year we will be taking storage-in on **Saturday, October 24, 2020** from **8 am to 11 am**. We will again this year stay at the \$10/foot (*from the most frontal point to the most distant point – this will include any hitches on the front or back of your item*) and we will have volunteers on hand to measure your item. As in years past, we ask that you be patient with our volunteers as we place you in our buildings.

Early-in Dates

If you are interested in early-in, we will have set dates for early in and you will need to make appointments in order to be taken on early-in dates, as our volunteers will only be there during the set times. Our early in dates are: **Sunday**, October 11, 2020, from 8 am – 10 am, **Sunday**, October 18, 2020, from 8 am-10 am, **Tuesday**, October 20, 6 pm – 8 pm, and **Thursday**, October 22, 2020, 6 pm – 8 pm. These dates have an extra charge of \$100 for the early-in fee (in addition to the regular storage fee of \$10/foot).

If you cannot make any of the 4 dates above for early-in, but would like to make other arrangements, there will be an early-in fee of \$150 in addition to the regular storage fee of \$10/foot.

Storage-out Date

Right now, I am setting the storage out date as **Saturday, April 10, 2021**. We may end up doing it by appointment, as we did in 2020, depending on weather and our volunteer situation, as well as the state of our area if the virus is still putting a damper on plans.

We will not be allowing early-out unless arrangements are made when you put your item in storage. Your item will then need to be put at the front of the storage area, and there are only so many placements at the front of the storage areas, so it will be a first-come, first-serve basis. If you require early-out, there will also be a surcharge of \$100 to open the building.

- Regular Charge \$10/foot
Measurement is from the most frontal point to the most distant point.
- Early In Fee \$100 + Regular Charge of \$10/foot
Sunday, October 11, 2020, 8 am – 10 am
Sunday, October 18, 2020, 8 am-10 am
Tuesday, October 20, 2020, 6 pm – 8 pm
Thursday, October 22, 2020, 6 pm – 8 pm
*You must make an appointment for one of these dates –
if we only have appointments until 7:00 pm, we will not stay until 8:00.*
- Early In Fee \$150 + Regular Charge of \$10/Foot
This charge is if you schedule for any other day outside of the above dates.
- Early Out Fee \$100 + Regular Charge of \$10/Foot
- Storage Fee for every week you do not pick your item up after April 10, 2021
\$50/week
